Law enforcement has been contacted and they are currently investigating.</p> <p>Today (3-22-14), ██████████ told CPS personnel that she went to the grocery store on 3/22/14. ██████████ called her and asked if he could go see one of his female friends (unknown information). ██████████ said no, but when she got home, ██████████ wasn't there. ██████████ called ██████████ and he said that he was with the friend anyway. ██████████ told ██████████ to come home and he did. ██████████ asked ██████████ to help her carry in the groceries. ██████████ said that he wanted to take a shower first. ██████████ says that ██████████ walked up the stairs and, in her words, "he fell dead." An autopsy is being completed according to ██████████. ██████████ was interviewed as well.</p> <p>Since minor's death has been classified as "Undetermined", law enforcement is investigating the circumstances of the death and has taken the lead in this investigation.</p> <p>██████████ had been on probation for fighting at school and using drugs (marijuana).
