On 7/14/13 [REDACTED] last name unknown/15 and two of his friends [REDACTED] and [REDACTED] were supposed to go the [REDACTED] but they did not go to the [REDACTED] and [REDACTED] with several other youth [REDACTED], [REDACTED] and [REDACTED] went to the [REDACTED] in [REDACTED]. While at the lake [REDACTED] reportedly jumped off the bluff under the bridge into the lake. [REDACTED] reported that [REDACTED] bobbed up to the surface a couple of times then went back under and did not resurface. None of the other youth were harmed or injured. [REDACTED] reported that [REDACTED] could not swim. [REDACTED] who was reportedly the one to drive everyone to [REDACTED] had spoken with her [REDACTED] and [REDACTED] reportedly, gave permission for all of the children to go to [REDACTED].
