She stated that he asked her again later and she asked him whose party was it and if he was sure he really wanted to go. She stated that he told her some of his friends were going and she told him okay. She stated that she went to the store to get some cigarettes for her sister and when she got back, he was gone. She stated that she asked where he was and her sister told her he left walking. She stated that she got dressed and left the home about 9:00-9:30 pm to go to ██████████ Sports Bar and Grill. She stated that she received a call about a couple of hours later from her sister, telling her that she needed to go the ██████████ Hospital because ██████████ had been shot. She stated that when she got to the hospital, she passed out because they told her he had died. She stated that the police and detectives were at the hospital and they wouldn't let her see him and she still hasn't seen him. She stated that she didn't know the kids that he was hanging out with. She stated that they were not his usual friends because she is familiar with them and is okay with him hanging out with them. She stated that her children don't be in the streets and they are always either at home or at her sister's house. ██████████ stated that she found out on that day that her son was affiliated with the Crips gang.

On 05/21/2013, the Department of Children's Services received a referral with the allegation of Abuse Death. The alleged victim is [REDACTED]. [REDACTED] was shot and killed at a party on 05/18/2013. The mother was interviewed and stated that left home about 9:30pm to go celebrate her birthday and he was at home when she left. She stated that he had asked her earlier about going to a graduation party and she told him no. She stated that when he asked her again later, she asked him who was he going with and if he was sure he wanted to go. She stated that he told her that he was going with some friends and she told him ok. She stated that she received a call later from her sister telling her that he had been taken to [REDACTED] because he had been shot. She stated that when she got there and they told her he didn't make it, she passed out. She stated that she didn't know the kids he was with, but she was familiar with his friends and was okay with them. [REDACTED] stated that her kids do not hang out in the streets and they are always at home, at her sister's house, or their uncle's house. She stated that she found out on that day that he was affiliated with the CRIPS gang. She stated that she had no idea that he was in a gang. The person responsible for shooting and killing [REDACTED] was questioned and charged with First Degree Murder on 05/19/2013. An Assessment case was open at the time of the child's death and several meetings were attempted with the mother, but to no avail. The mother and her two daughters are currently staying with a sister located at [REDACTED]. The two girls are enrolled at [REDACTED] High School. After investigating this case, the allegation of Abuse Death is unable to be substantiated. The autopsy results state the cause of death is gunshot wound of the torso and the manner of death is homicide. This case was a homicide by a gang member in the community. All necessary investigative tasks have been completed. This case is being submitted to TL for review.

On 5/21/13 this TL, [REDACTED] along with [REDACTED], DRA and [REDACTED] met with [REDACTED], FSW2 to discuss the recent death of [REDACTED] and the current case status. During this meeting [REDACTED] reported that he has not been able to locate [REDACTED] nor his mother since February 2013 as he made several attempted face to face contacts to their residence to find the home empty. [REDACTED] reported having made telephone contact with [REDACTED] maternal aunt (name ukn) regarding the whereabouts of him and his mother and was told that she had no knowledge of their whereabouts.

[REDACTED] stated that after being unsuccessful in locating this youth during the last month of his Aftercare he decided to prepare the case for closure and submit to this TL for approval. Unfortunately, [REDACTED] never staffed this case with [REDACTED] nor this supervisor regarding the youth's absconder status and elected to ensure appropriate case direction concerning the violation status of this Aftercare.

During this meeting [REDACTED] also reported having made contact with [REDACTED], JVC Probation officer in April 2013 regarding [REDACTED] whereabouts and was informed that she too has been unable to locate this family as of late. In so doing, [REDACTED] further affirmed via his efforts to submit this Discharge request that [REDACTED], DOB [REDACTED] met the requirements of DCS and of the committing court and was a proper person to be discharged from the supervision of DCS. The team discussed the case and came to the conclusion to submit the case to the court for discharge because the child had completed treatment and his 30 day trial home visit and the in- home provider had requested case closure a few weeks ago saying the mother and child say they no longer needed in-home services and the child was following the rules in the home.

The FSW Planned to follow up with submitting the discharge papers to court after revisiting the previous address of the family.
