<p>On 9/21/2013 at 10:05 PM, ██████████ deputies responded to a shooting on ██████████ in ██████████. They found ██████████, 50, at his neighbor's home. He had been shot in the hand and abdomen. The shooter, ██████████'s girlfriend ██████████, was still in their home at ██████████. A deputy drove his squad car up the driveway, his headlights revealing a ██████████ on the porch with a handgun. She fired two shots at the ██████████ deputy, but missed him. He took cover and stayed down until backup arrived around fifteen to twenty minutes later. ██████████ then talked to ██████████ on the PA system, trying to get her to come out. The officers didn't realize that 6-year-old ██████████, ██████████'s daughter, was in the home with her until around 2 AM while speaking with neighbors. Deputies went into the house and found ██████████ had escaped with ██████████ into the woods behind the home. The sheriff's department, along with the help of the ██████████ with a heat seeking system, searched for ██████████ and her mother until 4:30 AM EST when fog came in and made it unsafe for the helicopter to continue. On 9/22/2013, Sunday morning, at 9 AM, the sheriff's office received a call. ██████████ and her daughter ██████████ lay dead in a nearby neighbor's driveway. They both had gunshot wounds to the head. ██████████' mother had two guns on her when their bodies were discovered. One was a .32 and the other, the one she appeared to have used, was a .22. ██████████ stated that it appeared to be a murder-suicide, but they are awaiting autopsy results.</p>

[REDACTED] was not in DCS states custody. [REDACTED] (6) lived with her mother, [REDACTED], and [REDACTED]'s boyfriend, [REDACTED]. The child had no known special needs / disabilities. [REDACTED] is deceased. [REDACTED] was likely killed early Sunday morning due to a single gunshot wound to the head. The mother is also deceased. The family was involved in a murder / suicide this weekend. [REDACTED] is currently at the [REDACTED]. He sustained two gunshot wounds. The incident started Saturday around 10 p.m. when the mother shot [REDACTED] in the stomach and the hand. There was a standoff between the mother and LE. It's not believed LE was aware [REDACTED] was with the mother. LE threw smoke bombs into the family's home. This forced the mother out of the home. The mother took [REDACTED] and ran into the woods. The police lost the mother and [REDACTED] in the woods. Early Sunday morning, LE received a phone call about two bodies (the mother and [REDACTED]) in a driveway at the neighbor's home. DCS staff became aware of the situation after a phone call from a relative (Aunt [REDACTED] last name unknown). Then reports were obtained through the news media. Officer [REDACTED] with the [REDACTED] Sheriff's Office also provided information about the situation. DCS has worked with the mother and [REDACTED] in the past. The most recent CPS case was in Dec. 2012. The mother and [REDACTED] have history with LE. The mother got released from jail the same day that [REDACTED]'s father, [REDACTED], went to jail. [REDACTED] is currently in the [REDACTED] Jail. [REDACTED] has a history of drug abuse. DCS drug screened [REDACTED] within the past year. She was negative at the time. DCS staff is waiting on the autopsy reports and other information about this situation.
