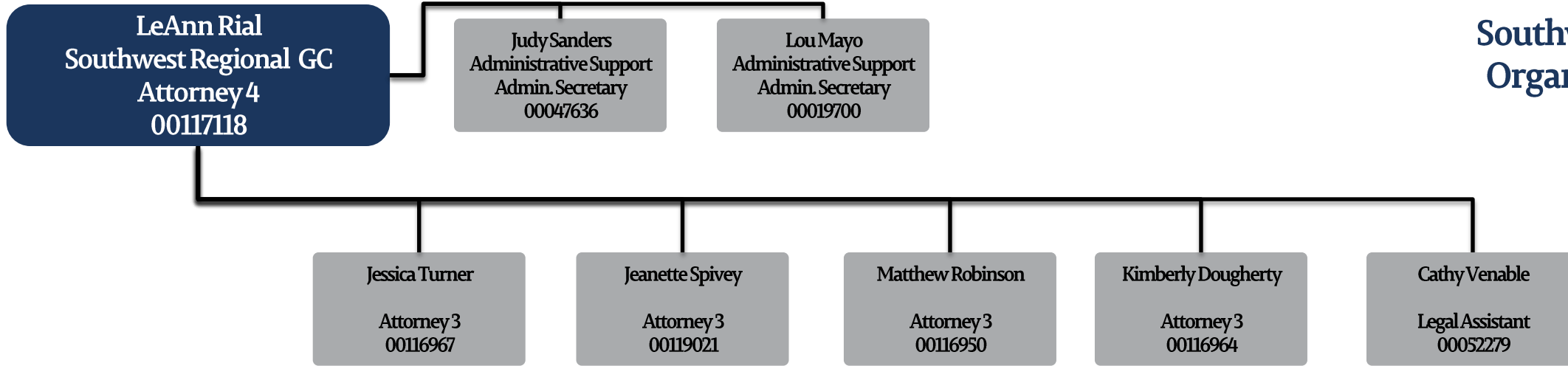
# Northwest – General Counsel Organizational Framework

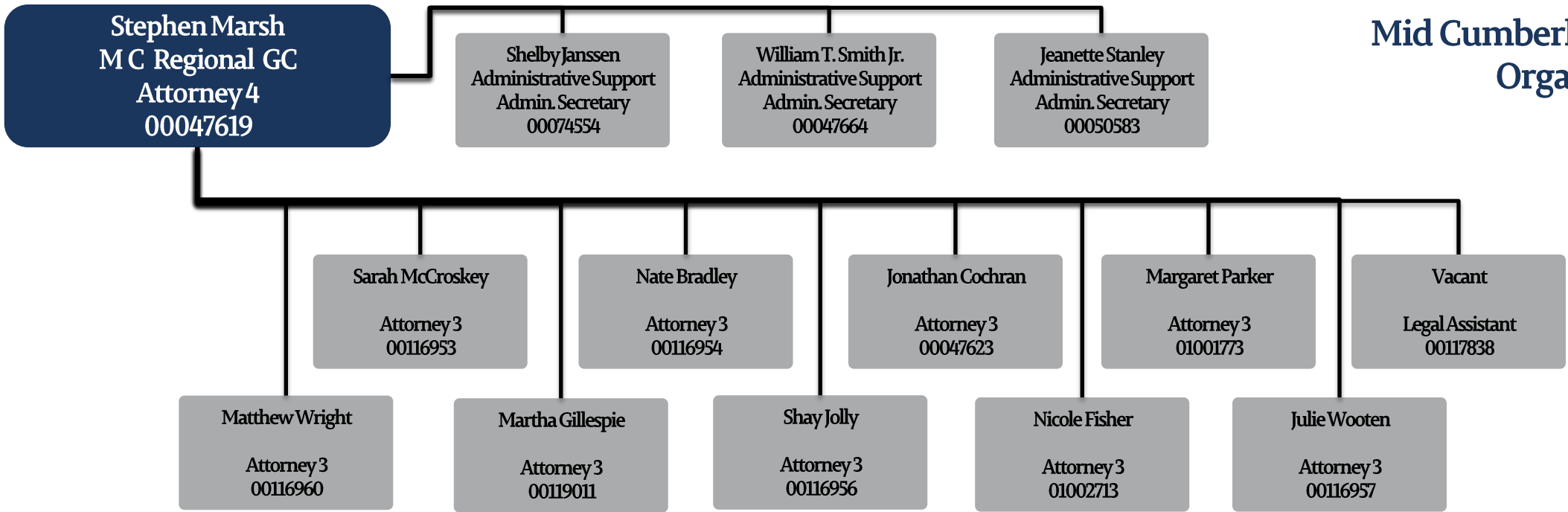

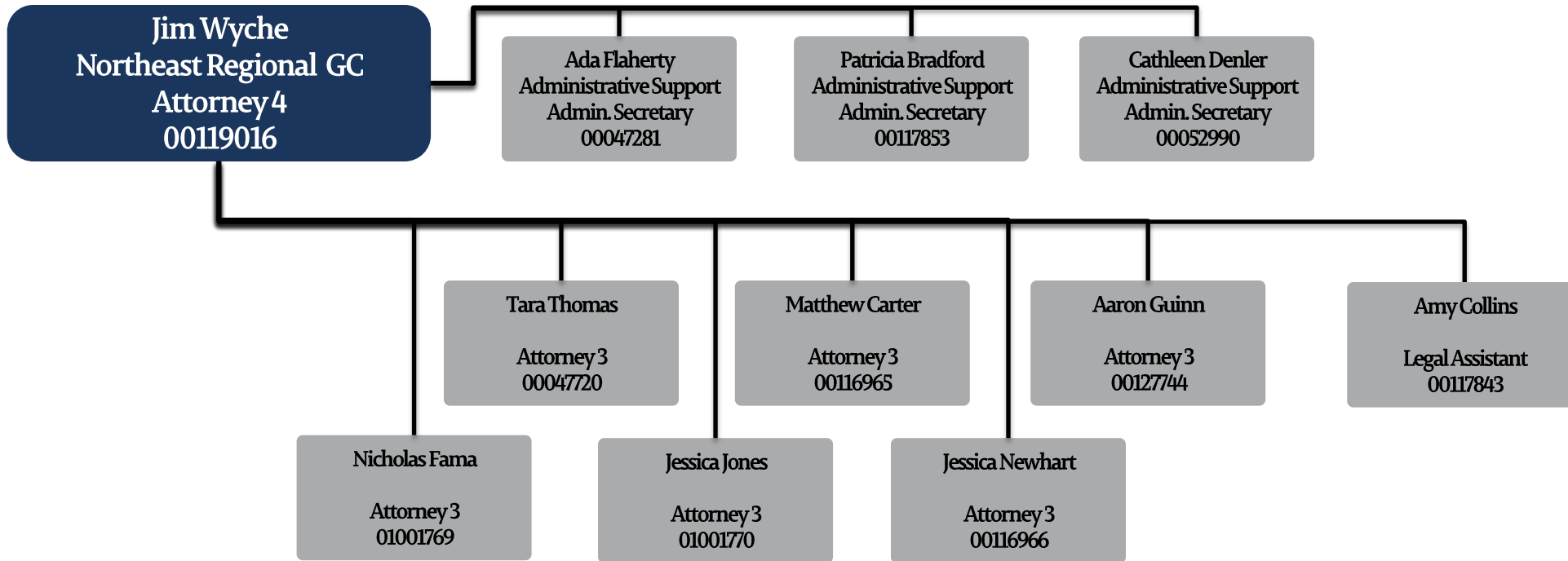

# Mid Cumberland– General Counsel Organizational Framework

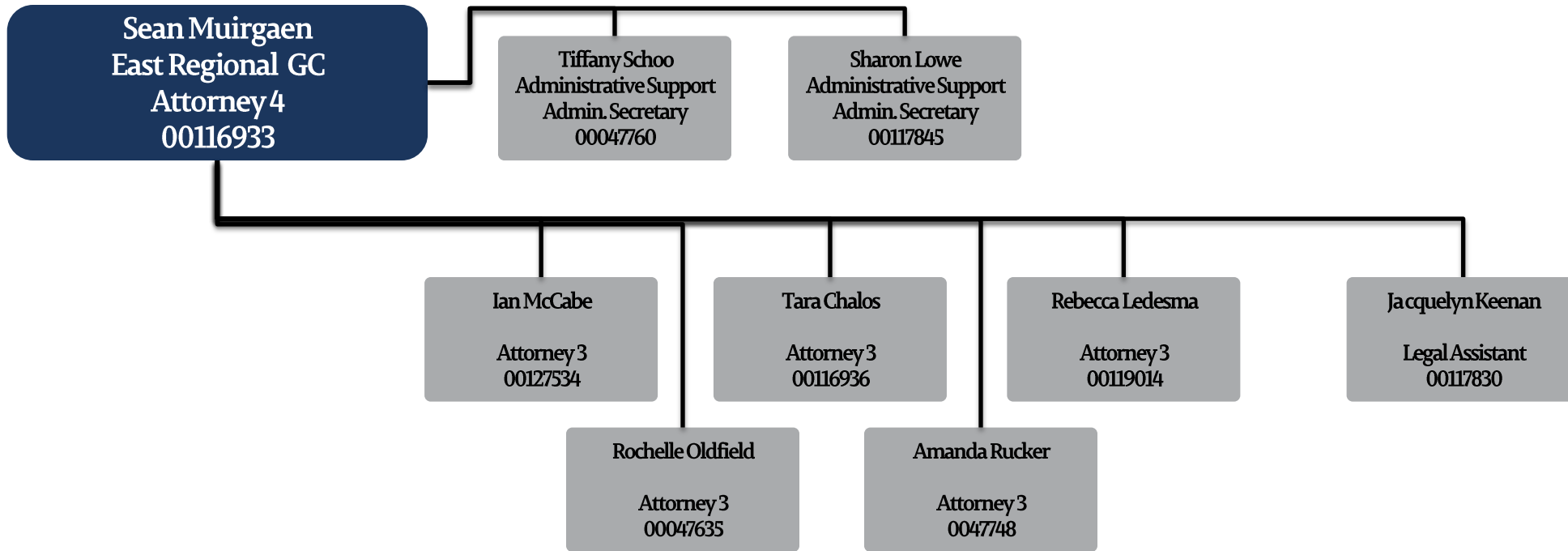




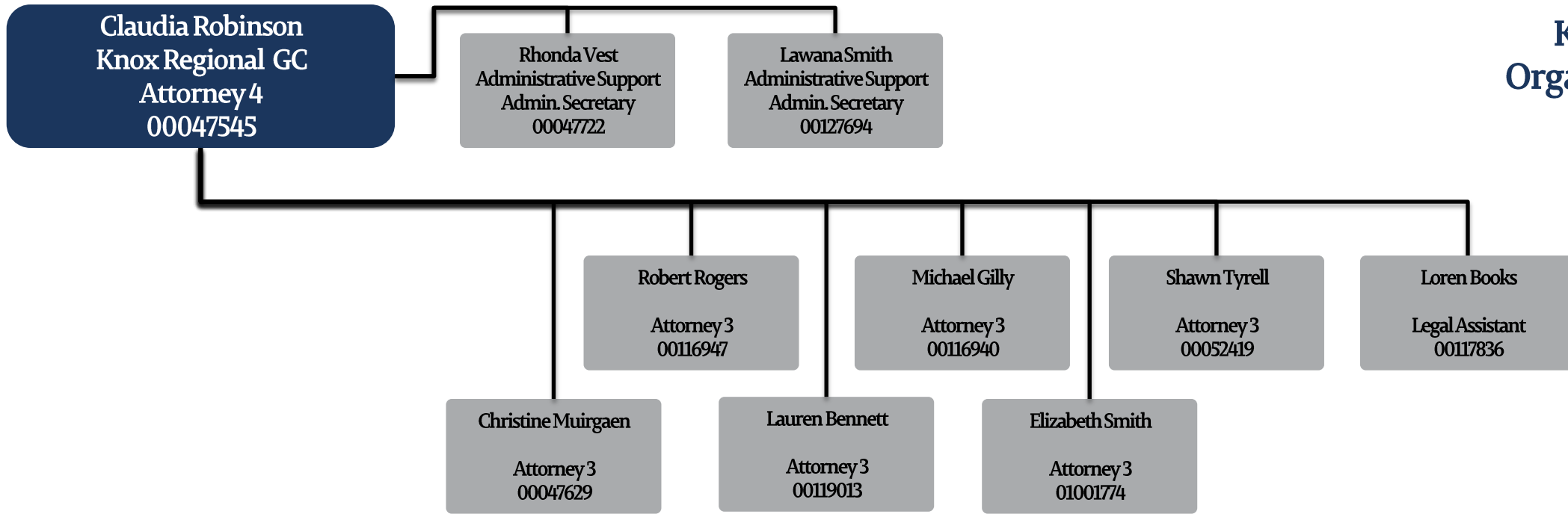
# Northeast- General Counsel Organizational Framework



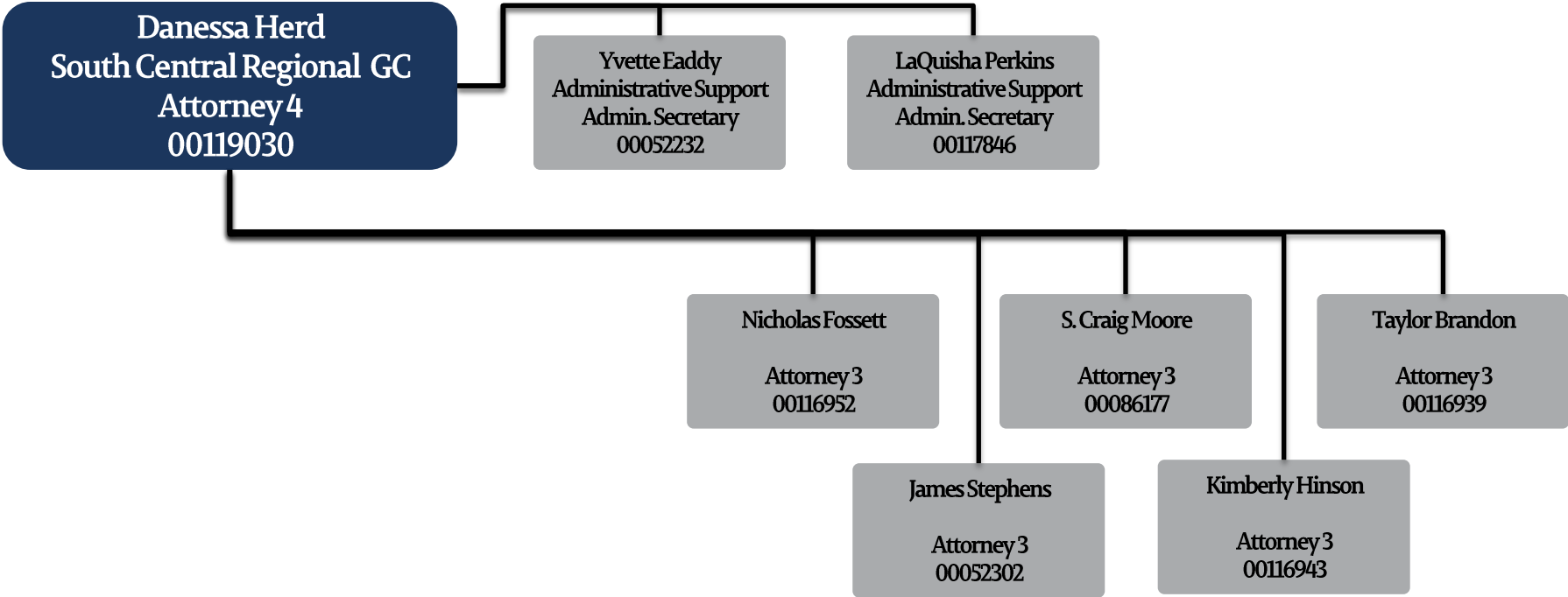
# East- General Counsel Organizational Framework



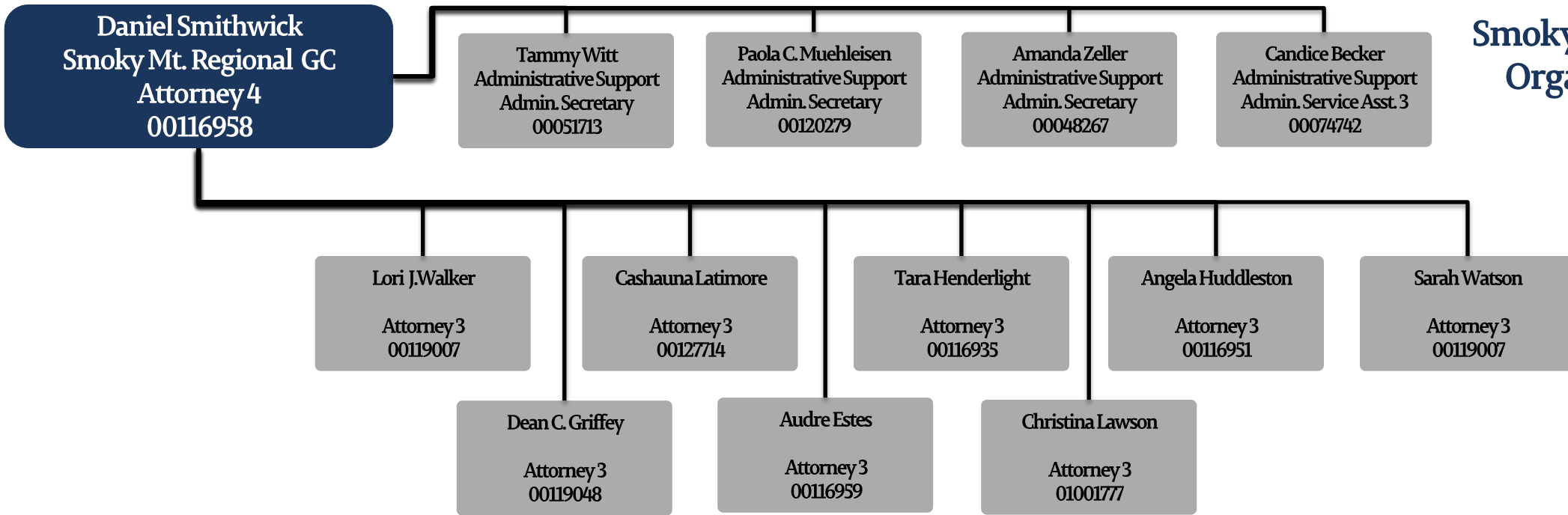
# Knox – General Counsel Organizational Framework



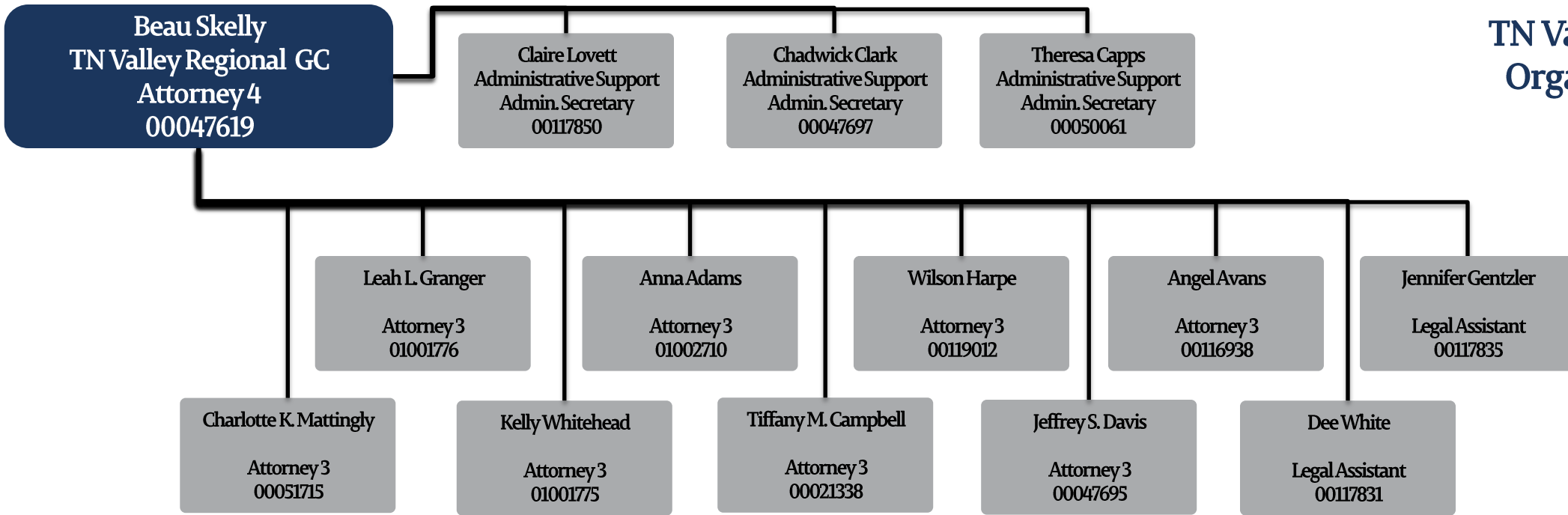
